



#### **UP FRONT**

During the July 20 QBM after the Sunday morning service, the Administrative Leadership Team (ALT) is offering the following motion: The Bylaws and relevant sections of the constitution be changed to eliminate the references to the LCT and the Ministry Teams and their responsibilities.

Any additional proposed changes, unrelated to this (but related to proposed updating) will be brought before the congregation in detail.

This proposal is consistent with the October 2024 QBM when the congregation voted to set aside the Bylaws and Constitution as related to the polity (the LCT and Ministry Teams) and to pilot the new policy where the ALT became responsible for the Administrative Leadership of the church. This vote included the agreement that in July 2025, the congregation would vote on making this polity enshrined in the bylaws and constitution or not.

The ALT consists of ELECTED moderator, vice-moderator, and both treasurers. In addition to elected members, two to three at

both treasurers. In addition to elected members, two to three atlarge members of CBC and the Pastor. The ALT meets at least twice each month. The ALT serves the church through hosting annual visioning sessions which result in the formulation of a series of

the church through hosting annual visioning sessions which result in the formulation of a series of Action Steps to be carried forth by Ad Hoc teams in the next year. Additionally, the ALT helps to assure that the Standing Teams are functioning effectively.

# The proposal to reimagine the polity came at the recommendation of our past Moderator, John Martin. Major changes have occurred since this original polity was conceived, including a limited number of ministry staff and continual difficulty filling all of the required positions for lay leadership. The new polity reflects a path forward which requires fewer required positions, but opens opportunities for each person in the congregation to participate in one or more Ad Hoc Teams or Standing Teams that fits their talents, desires and time.

# Summer Series on the Season Between This Life and the Next

#### **End of Life Issues- Exit Right**

On July 20, the second in our four-part series on End-of-Life issues will take place at 9:15 a.m. in Merriam Hall. The July 20 session will feature Reverend David R. Nicholson who is a

Board Certified Chaplain and the Retired Senior Staff Chaplain at Memorial Medical Center in Springfield. He will be joined by Rev Jerry Phillips who also has extensive training in nursing homes, hospice and hospital settings. They will address spiritually related topics such as: Is it okay for me to be Cremated? How can I address the needs of the family during this season? How do we best handle grieving? and other related topics.

We plan to examine additional topics in August and September (see dates below). For those who would prefer not to deal with these topics at this time, an alternative Sunday School class will be available. A resource table on the topics will also be in Merriam Hall. Topics that will be or have been discussed during the four sessions include:

June 22, End-of-Life Care services available

July 20, Spiritual Issues and related topics at end-of-life.

August 24, Financial and Legal Issues at end of life - what do I want to happen to my resources, wills and trust and legacy giving.

September Date TBA - Preplanning for events following death - including what should happen to my body after I die, and who will take care of my funeral and/or celebration of life, and sacred places we wish to be buried or have our ashes placed/scattered.

We hope you will join us for these sessions that will feature experts from outside the church on each topic. We invite you to bring members of your family or guests to join you in the sessions.
